

# Affidavit – Volunteer Exemption from FBI Certification

I, \_\_\_\_\_, swear or affirm that I am applying for an unpaid volunteer position with \_\_\_\_\_ (organization) and as part of my duties I will be responsible for the welfare of children or will have direct contact with children.

I understand that the Child Protective Services Law requires all volunteers to complete three (3) background clearances: (1) Department of Human Services Child Abuse Clearance; (2) Pennsylvania State Police criminal background clearance; and FBI criminal background clearance.

I further understand that the law may exempt a prospective volunteer from the federal clearance if I: (1) **have been a Pennsylvania resident during the entirety of the previous 10-year period or, if not a resident of Pennsylvania during the entirety of the previous 10-year period, have received certification under section 6344(b)(3) (volunteer certification) at any time since establishing residency in Pennsylvania and I provide a copy of the certification to the person responsible for selecting volunteers** and (2) **swear or affirm in writing that I am not disqualified from service by reason of criminal history** and I hereby Swear or Affirm that:

(a) I have not been named in the statewide database maintained by the Dept. of Human Services as the perpetrator of a founded or indicated child abuse report committed within the five-year period immediately preceding verification. I have requested a child abuse background clearance from the Dept. of Human Services and a criminal background clearance from the Pennsylvania State Police. I am attaching copies of my clearances here. I understand that I will be required to produce original clearance reports before beginning service; and

(b) I have been a resident of Pennsylvania during the entire previous ten-year period and have not been arrested for or convicted of any of the offenses below or crimes similar in nature, or the attempt, solicitation, or conspiracy thereof, or a similar offense under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico, or a foreign nation, or under a former law of this Commonwealth:

(c) I further swear that I have not been arrested for or convicted of a felony drug offense under the Controlled Substance, Drug, Device and Cosmetic Act.

(d) I understand that I may be accepted to serve on a provisional basis for a single period not to exceed thirty (30) days at the discretion of the organization. I swear or affirm that I am in compliance with the clearance standards under the law of the jurisdiction where I am domiciled. I further understand that, during any provisional period, I may not work alone with children and that I must work in the immediate vicinity of a permanent employee of the school.

**I hereby swear or affirm that the information set forth above is true and correct to the best of my knowledge and belief. I understand that if information is obtained that I am disqualified from service, I will be dismissed immediately. I also understand that I am signing this document subject to penalty under Sections 4903 of the Pennsylvania Criminal Code (false swearing).**
